Testimony of *Charles Louis Hest.* Lyon, September 5, 1944. 1 p. 4to carbon copy on onion skin. Account of his activity as a collaborator.

Testimony of Charles Louis Hest. Lyon, September 24, 1944. 1 p. 4to carbon copy on onion skin. Autograph signature of Hest. Account of his collaboration with the Germans including denouncing his own brother. Same prisoner but different account from the previous document. A note in pencil reads "fusillé" [shot]!

Testimony of *Joseph Simplet.* Lyon, September 29, 1944. 1 p. 4to carbon copy on onion skin. Account of actions against Jews. A note in pencil reads "fusillé" [shot]. ! and another reads "a arrêté la petite Berthe Wartsky, 15 ans" [arrested the young Berthe Wartsky age 15].
